Published by the European Commission, the publication focuses on travel in Europe: a continent with thousands of years of history, a rich cultural heritage and some of the world's most breathtaking scenery.

Exploring the diversity of NEETs

Published by Eurofound, the report emphasises the importance to focus on the specific needs of different groups of young people who are NEET (young people not in employment, education or training). The report, which is accompanied by a country by country overview, presents an upto-date picture of the situation of NEETs in the EU and includes an analysis of NEET rates over time, the gender composition of the NEET group, educational attainment, and risk of social exclusion. With regards to the current status of NEETs, it shows that fewer than one in three NEETs across the EU are short-term unemployed, more than one in five are now long-term unemployed and roughly the same proportion are NEET due to family responsibilities, or due to illness or disability. The report examines the NEET indicator and uses EU Labour Force Survey data to disaggregate the NEET population into seven subgroups, providing an analysis based on the data available for each subgroup and describing the composition and characteristics of Europe's NEET population at both EU28 level and in each Member State. The report shows that the composition of NEETs varies greatly across Europe and argues that a comprehensive effort is needed to understand the diversity of NEETs as the various subgroups within the NEET category have very different characteristics and needs.

Study on the Social value of youth organisations

Published by the European Youth Forum, the publication aims to gather evidence from existing research on the role youth organisations play in both developing the potential of young people as members of society and in terms of the impact they make on society. It collects evidence that may support the work of the European Youth Forum in raising societal interest around the role of youth organisations; as well as evidence on the costs and benefits of investing in youth organisations and on the social impact of the educational role of youth organisations.

OECD Employment Outlook 2016

The OECD publication provides an in-depth review of recent labour market trends and short-term prospects in OECD countries. The report looks at recent labour market developments focusing on on vulnerable youth who are neither working nor in education or training. The size of this group has grown in recent years in many OECD countries and governments will need to take vigorous policy measures if they are to meet the target, recently adopted by G20 governments, of reducing the share of youth who are vulnerable by 15% by 2025. The report looks at if countries are doing enough to assure that workers are able to make full use of their skills on the job. It examines the short-term effects of structural reforms on employment and identifies successful strategies for reducing transition costs. Finally it discusses how to close the labour market gender gap in emerging economies, proposing a comprehensive policy response to the problem. The Outlook's analysis and recommendations are complemented by a statistical annex.

The OLS language courses include a variety of self-paced modules covering different linguistic areas, as well as "Live Coaching" interactive activities (online MOOCs, tutoring sessions and forums). Tvebiomovies 2016

Traineeships at the European Commission

The European Commission (or some executive bodies and agencies of the European Institutions like, for instance, the European External Action Service or Executive Agency for Competitiveness and Innovation) organises twice a year in-service training periods lasting five months for university graduates. The training periods start on 1st March and 1st October each year. Trainees will receive a monthly grant of approximately €1,120 and reimbursement of travel expenses. Accident and health insurance can also be provided. The traineeship programme is open to university graduates, from all over the world who have a:

- Degree of at least 3 years of study (minimum a Bachelor);
- Very good knowledge of English or French or German (C1/C2 level in accordance with the Common European Framework of Reference for Languages);
- Very good knowledge of a second EU official language (required for nationals of EU countries).

Highlights

#AskNavracsics-helping more young people to engage in their communities

Commissioner Tibor Navracsics, the European Commissioner for Youth, wants to help more young people to engage with their communities through volunteering and other activities. He recently discussed the broad issues with a number of young people online and in person, and now he would like to hear from many more young people across Europe.

He wants to hear young peoples' ideas and opinions on how to make it easier for them to get involved in their communities. These will be used by him and his staff to influence policies and practices at European and national levels. His discussions with young people, along with more formal research into this topic, has highlighted some of the things that discourage young people from getting involved in their communities through volunteering and other activities, including:

- A lack of motivation and information about how to start volunteering;
- Too few role models that young people can be inspired by;
- Not enough information on the opportunities and projects that are available;
- The costs of taking part;
- Very little recognition of all the effort put in;
- Little acceptance by potential employers of the new skills gained through getting involved.

Participants to the consultation will have to give their views on what should be done to reduce or remove these barriers, and any others that make it difficult for young people to engage in their communities.

Public Consultation on the Evaluation of the Youth policy cooperation in the EU

Launched by the European Commission, the consultation is about how European Union (EU) countries work together on policy for young people. The consultation aims to know how useful and effective the EU youth policy is.

Respondents are invited to give their views about the EU Youth Strategy (2010-2018) and the EU Council Recommendation on the mobility of young volunteers in the EU and what they think about these initiatives, and how to improve cooperation on youth policy.

The results of the consultation will be used to plan future EU youth policy measures. A Staff Working Document, including a summary of the results of the consultation, will be published by the end of 2016.

European Parliament assesses the EU Youth Strategy

On 13th July 2016, in a meeting of the European Parliament's Committee on Culture and Education (CULT), MEPs adopted a report on the Assessment of the EU Youth Strategy 2013-2015.

The report stresses the importance of the Structured Dialogue as a tool for youth participation and the crucial role of youth organisations in policy making in view of the next Youth Strategy from 2019 onwards.

The report calls for investment in young people and youth policies, as well as more coherence between the various EU strategies and programmes in order to achieve a truly cross-sectoral mainstreamed European youth policy. It also asks for benchmarks to increase incentives for Member States to improve their national youth policies and implement the Youth Strategy.

On the same day, the CULT Committee also had an exchange of views on the Erasmus+ Implementation, in order to prepare for the European Parliament's Erasmus+ Implementation Report.

Two studies on the implementation of the Erasmus+ Programme were presented: the Research for Cult Committee - Erasmus+: Decentralised <u>Implementation - First Experiences and The Erasmus+ Programme</u> European Implementation Assessment. http://bit.ly/2ac6ebP

Lifelong Learning Platform Erasmus+ Survey

Organised by the Lifelong Learning Platform, the survey aims to provide decision-makers with feedback from the programme's direct beneficiaries on what works and what could be improved. Europeans in 2016: Perceptions and expectations, the fight against terrorism and radicalisation

According to a special Eurobarometer, carried out by the European Parliament, on the perceptions and expectations Europeans have regarding the EU's action, the fight against terrorism and the mutual defence clause, the fight against terrorism should be the EU's number one priority followed by action on unemployment, the fight against tax fraud, migration, the protection of external borders and the environment. The survey was conducted in the 28 Member States of the European Union, from 9th to 18th April 2016, by TNS opinion.

Eurostat release on vocational education

According to a new release from Eurostat, the statistical office of the European Union, of the 22 million pupils in the European Union (EU) studying at upper secondary level in 2014, almost 11 million (or 48%) were enrolled in vocational education. In twelve EU Member States, more than half of all upper secondary pupils studied vocational programmes. Vocational education at upper secondary level was somewhat dominated by men, who accounted for 56% of pupils, compared with 44% women. This pattern can be observed in almost all Member States. Across Member States in 2014, the highest proportion of pupils at upper secondary level enrolled in vocational education was registered in the Czech Republic. The majority of pupils following vocational upper secondary programmes were men in every EU Member State, except Belgium (52% were women), Finland and the United Kingdom (both 51%) as well as Sweden (where the gender distribution was balanced).

On 29th June, the two High Level Groups established last year by Commissioner Navracsics delivered their final reports. Both documents include diverse recommendations addressed to the Commissioner. The report on sport diplomacy identifies how sport can play a more significant role in helping the EU reach its external policy goals as well as how sport

could be a tool to promote European values. The report and recommendations on grassroots sport deal with issues which are fundamental to the contribution grassroots sport can make to European health, social inclusion, informal learning development, volunteering, sustainable financing, urban planning and infrastructure.

During the handing-over ceremony, Commissioner Navracsics thanked the members of both groups for their work and for the high quality of the documents.

Eurostat release: May 2016 Euro area unemployment rate

According to Eurostat, the statistical office of the European Union, in May 2016, 4.197 million young persons (under 25) were unemployed in the EU28, of whom 2.885 million were in the Euro area. Compared with May 2015, youth unemployment decreased by 503 000 in the EU28 and by 270 000 in the Euro area. In May 2016, the youth unemployment rate was 18.6% in the EU28 and 20.7% in the Euro area, compared with 20.6% and 22.4% respectively in May 2015. In May 2016, the lowest rates were observed in Malta (6.9%), Germany (7.2%) and the Czech Republic (10.1%), and the highest in Greece (50.4% in March 2016),

Spain (43.9%), Italy (36.9%) and Croatia (31.4% in the first quarter 2016).

EU Employment and Social Situation - Quarterly Review - Summer 2016

The summer edition of the Employment and Social Situation Quarterly review (ESSQR), published by the European Commission, confirmed an increase of the overall employment rate, for both the EU and the Euro area, an increase representing 3 million more employed people in the EU than one year before. The overall long-term unemployment rate, at the other hand, decreased by 0.6 percentage points compared to a year before and stands now at 4.3% of the labour force. This is the largest reduction since the first decline in long-term unemployment observed in 2014. In addition, for the first time since the start of the economic recovery, the number of long-term unemployed dropped more strongly than the number of people unemployed for less than two years. Finally, this season's edition also shows a continuous improvement and convergence among Member States regarding youth unemployment, which has decreased more strongly in countries most affected by the crisis.
