Erasmus+ Annual Report 2016

Published by the European Commission, the Report confirms the key role played by the programme in building a more resilient Europe united around common European values. With a 7.5% increase in the Erasmus+ budget compared to the previous year, the EU invested a record €2.27 billion to support 725,000 Europeans with mobility grants to study, train, teach, work or volunteer abroad. This brings the total to more than $\in 2$ million since 2014. In 2016, 21,000 projects received funding involving 79,000 education, training and youth organisations -15% more projects than in 2015.

The Report argues that Erasmus+ is well on track to meet its target of supporting 3.7% of young people in the EU between 2014 and 2020. It also shows that the programme has the potential to contribute to making mobility while learning a norm, a goal set out by the Commission in its Communication on "Strengthening European Identity through education culture" discussed by the EU leaders at their Working Lunch in Gothenburg on 17th November. In the 2015/2016 academic year, Erasmus+ enabled higher education institutions to send and receive 330,000 students and staff, including 26,000 to and from partner countries. France, Germany and Spain were the top three countries in terms of sending students and staff, while Spain, Germany, and the United Kingdom were the three most popular destinations. The Report also shows how Erasmus+ contributed to respond to wider social challenges in 2016. This includes actions to promote social inclusion and ensure that young people acquire social, civic and intercultural competences and learn to think critically. http://bit.ly/2AIV4ui

Education and Training Monitor 2017

The 2017 edition of the European Commission annual Report on how the EU's education and training systems are evolving shows that, while Member States are making progress towards most of the key EU targets in reforming and modernising education, more efforts are needed to achieve equity in education. The report also shows that in 2016 only 44% of young people aged 18-24 who had finished school at lower secondary level were employed. In the general population aged between 15 and 64, the unemployment rate is also much higher for those with only basic education than for those with tertiary education (16.6% vs. 5.1%). At the same time, socio-economic status determines how well pupils do: as many as 33.8% of pupils from the most disadvantaged socio-economic backgrounds are low achievers, compared to only 7.6% of their most privileged peers.

One of the EU's targets for 2020 is to reduce the share of 15year-old pupils who underachieve in basic reading, maths and science to 15%. However, as a whole, the EU is actually moving further away from this objective, particularly in science,

where the number of low achievers increased from 16% in 2012 to 20.6% in 2015. People born outside the EU are particularly vulnerable. This group is often exposed to multiple risks and disadvantages, such as having poor or low skilled parents, not speaking the local language at home, having access to fewer cultural resources and suffering from isolation and poor social networks in the country of immigration. Young people with a migrant background are at a greater risk of performing badly at school and leaving school prematurely. In 2016, as many as 33.9% of people aged 30-34 living in the EU but born outside it were low skilled (having achieved lower secondary education or below), compared to only 14.8% of their peers born in the EU. Across the EU, investment in education has recovered from the financial crisis and increased slightly (1% year-on-year in real terms). About two-thirds of Member States recorded a rise. Four countries increased investment by more than 5%. The report comprises a cross-country comparison, 28 in-depth country reports, and a dedicated webpage with additional data and information.

Study on the contribution of sport to the employability of young people in the context of the Europe 2020 Strategy

The study, commissioned by the European Commission and the Executive Agency for Education, Audiovisual and Culture, investigates sport's contribution to the employability of disadvantaged young (NEETs) in the context of the Europe 2020 strategy. The aim is to identify the key components needed to effectively produce outcomes regarding employability in sportbased programmes for young people. An in-depth investigation of 10 selected case study organisations was conducted in 8 different European Member States. A theoretical framework provided the basis for data collection and analysis. In total, 85 in-depth interviews in 4 different languages were conducted with programme designers, social workers, sport coaches, participants and former participants. Documents, field notes and follow-up interviews provided more understanding of the complexity of the workings of each case study organisation and their programme. A generic 'programme theory' for optimal sport for employability programmes was then developed which identified the key components, mechanisms, relationships and a presumed sequence of causes and effects. Because of its normative nature, the theory serves as a set of guiding principles and recommendations. It can be used as a robust basis for monitoring and evaluation of existing programmes, as well as to optimise design and implementation of future initiatives. Insights from this study also provided the basis for a number of policy recommendations.

This report the result of meetings with experts in political communication and European affairs, as well as bilateral interviews with individuals and organisations in the area of civil participation and communication. Traineeship at the European Railway Agency

European Disability Forum - Oracle E-Accessibility Scholarship for Students with **Disabilities**

The scholarship is addressed to students with disabilities who are currently enrolled in a high education programme in the area of Computer Science, Computer Engineering, User Experience, or related field. This includes Bachelors, Masters and PhD students. The recipient of the EDF - Oracle e-Accessibility Scholarship will receive a €7,000 scholarship for the 2017-2018 academic year. Highlights

Erasmus+30 years Celebrations

On 30th of November the closing of the campaign celebrating the 30th anniversary of the Erasmus programme and the presentation of the Erasmus+ Generation Declaration on the future of Erasmus+ took place. Throughout 2017 more than 750,000 people took part in over 1,900 events in 44 countries to celebrate and discuss the future of Erasmus+: 65,000 articles on the programme were published and shared over two million times on social media, reaching over 90 million people. The new Erasmus+ Mobile App, launched in June 2017, has already been downloaded more than 22,000 times. In Gothenburg, President Juncker invited the EU leaders to double the number of young people in the EU participating in Erasmus+ by 2025, which will require a budget of €29.4 billion for the period 2021-2027. During their meeting, EU leaders agreed to step up mobility and exchanges, including through a substantially strengthened, inclusive and extended Erasmus+ programme for all categories of learners. The Commission also invited the Erasmus+ Generation to engage in the debate and created the Erasmus+ generation online meeting point. Their discussion resulted in 30 recommendations on how to make Erasmus+ a bigger programme with a bigger impact on the future of Europe. The Declaration drawn up by the Erasmus+ Generation was officially presented and debated during the closing event of the anniversary campaign. http://bit.ly/2juDyPd

Future of Europe: Towards a European Education Area by 2025

With the debate on the future of Europe in full swing, the European Commission has adopted a communication setting out its vision for how to create a European Education Area by 2025. The Commission believes that it is in the shared interest of all Member States to harness the full potential of education and culture as drivers for job creation, economic growth and social fairness as well as a means to experience European identity in all its diversity. The Commission believes that education and culture can be an important part of the solution in tackling the challenges of an ageing workforce, continued digitalisation, future needs for skills, the need to promote critical thinking and media literacy in an era where "alternative facts" and disinformation can proliferate online, as well as the need to foster a greater sense of belonging in face of populism and xenophobia. A European Area of Education should include:

- Making mobility a reality for all
- The mutual recognition of diplomas
- Greater cooperation on curricula development
- Improving language learning
- Promoting lifelong learning
- Mainstreaming innovation and digital skills in education
- Supporting teachers
- Creating a network of European universities
- Investing in education
- Preserving cultural heritage

Helping people with disabilities: MEPs advocate positive discrimination

In a Resolution voted on 30th November, MEPs urge the EU and its member states to step up their efforts to put the European disability strategy commitments fully into practice.

The Resolution assesses the workings of the Commission's European Disability Strategy 2010-2020 and lists key actions in its eight priority areas: accessibility, participation, equality, employment, education and training, social protection, health and external action. People with disabilities have the right to equal treatment, to live independently and to be full members of society but, in spite of a high number of programmes and laws, they are still not enjoying their rights in full.

Priority measures suggested to the EU Commission and/or the member states include:

- making the 112 emergency number fully accessible,
- ensuring that public spaces are fully accessible in all member states,
- introducing positive discrimination, like a quota for persons with disabilities for jobs in the public and private sectors.
- giving special attention to women and girls with disabilities, as they often face double discrimination,
- ensuring that young people with disabilities can take part fully in EU initiatives such as Erasmus+, the Youth Guarantee and European Solidarity Corps, and training for educational staff to support persons with more complex needs.

The announcement of the winner of EYC 2020 was made at the Award Ceremony in Cascais, Portugal, EYC 2018.

Education, Youth, Culture and Sports Council, 20th-21st November 2017

The Education, Youth, Culture and Sport (EYCS) Council, bringing together the education, youth, culture, communication and sport Ministers of the EU Member States, met in Brussels on 20th and 21st November. The Council reached a general approach on the proposal for a Regulation on the European Solidarity Corps, the new EU initiative aiming to support volunteering and work experience opportunities for young people.

The Council adopted Conclusions on smart youth work, calling for the creation of tools that young people can use to prevent and manage risks in the digital age. Ministers also discussed issues of concern to young Europeans and how the EU can help to address them. The Presidency will forward the key messages from this debate in a letter to the Presidents of the European Council, European Commission and European Parliament.

In the field of education, the Council adopted Conclusions on a renewed agenda for higher education. The overall aim is to modernise higher education so that it keeps pace with the rapidly evolving environment. It also adopted Conclusions on school development and excellent teaching. The Conclusions highlight the importance of ensuring high-quality and inclusive education for all, empowering teachers and school leaders, and shifting towards more effective, equitable and efficient governance. The Council adopted a Recommendation for tracking graduates as a way of encouraging and supporting member states in their efforts to improve the quality and availability of information on what graduates do after leaving higher education or vocational education and training. The Conclusions and Recommendation follow the Commission Communications of 30th May 2017 on school development and excellent teaching, and on a renewed EU agenda for higher education.

In the field of culture, the Council discussed how culture can contribute to making European societies more cohesive. In particular, Ministers discussed what can be done jointly at European level to reinforce action at the national level as well as the specific role of cultural and heritage organisations. Ministers were also informed about the state of play of negotiations with the European Parliament on the review of the Audiovisual Media Services Directive, which governs the EU-wide coordination of national legislation on all audiovisual media, both traditional TV broadcasts and on-demand services. The Council also adopted Conclusions on promoting access to culture via digital means. The Conclusions highlight the opportunities presented by new technologies for cultural organisations in terms of better

targeting existing audiences or reaching out to new ones. In the field of sport, Ministers discussed the main challenges facing sport in the 21st century. They looked at how to improve cooperation between national governments and with sports organisations in order to respond more effectively to issues such as integrity, governance and the contribution of sport to society. The President of the International Olympic Committee (IOC), Thomas Bach, took part in the debate in the Council for the first time since it has existed in this configuration. The Council also adopted Conclusions on the role of coaches in society as well as a Resolution aiming at further developing the existing high-level structured dialogue between EU institutions, member states' authorities and the sports movement. http://bit.ly/2mOidWb

2018 EU budget adopted

On 18th November the EU institutions reached an agreement on the 2018 EU budget. The EU budget helps turn political priorities into a reality. The adopted 2018 EU budget will go to stimulate the creation of jobs, especially for young people, and to boost growth, strategic investments and convergence. The EU will also continue supporting the efforts to effectively deal with the migration challenge, both inside and outside of the EU.

The 2018 EU budget is set at €160.1 billion in commitments (money that can be agreed in contracts in a given year) and €144.7 billion in payment credits (money that will be paid out). http://bit.ly/2zMVvCR

Survey on Youth Information Service Users

In the framework of Erasmus+ project #YouthInfo: Future Youth Information Toolbox, ERYICA project partners are currently carrying out a survey on identifying youth information needs, trends and relevant topics.

The survey is for young people from the age of 15 to 29. The aim is to find out if they have ever used a Youth Information Centre or any of its services, to know what they think of the help and support provided by youth information services and to better understand information behaviour i.e. what sort of information young people generally look for, what sources they use, which are their preferred form of information and how easily they can access these

The survey is available in different languages and will be open until 14th December 2017.

The results will be compared and contrasted with an ERYICA survey which was carried out in 2013, and will use future foresight methodology to identify a strategic direction for youth information.

Eurostat release: October 2017 Euro area unemployment rate

According to the latest figures published by Eurostat, the statistical office of the European Union, in October 2017, 3.722 million young persons (under 25) were unemployed in the EU28, of whom 2.657 million were in the Euro area. Compared with October 2016, youth unemployment decreased by 380,000 in the EU28 and by 201,000 in the Euro area. In October 2017, the youth unemployment rate was 16.5% in the EU28 and 18.6% in the Euro area, compared with 18.2% and 20.3% respectively in October 2016. In October 2017, the lowest rates were observed in Germany (6.6%) and the Czech Republic (7.2%), while the highest were recorded in Greece (40.2% in August 2017), Spain (38.2%) and Italy (34.7%). http://bit.ly/2jxn6xM
