Study on the impact of transnational volunteering through the European voluntary service

The study analyses the impact of EVS on individuals, organisations and local communities. It describes how 5 different types of EVS volunteers - 'Standard students', 'Mediterranean students', 'Experienced workers', 'Disadvantaged jobseekers' and 'Western pupils' - benefit differently from EVS. The study shows measurable impact of EVS on the volunteers' learning and competence development e.g. as regards languages as well as career and work-related aspects while identifing several options to further improve its impact with a specific focus on the role of young people with fewer opportunities. http://bit.ly/2qVd7FK

2017 Key Data on Teaching Languages at School in Europe

Published by Eurydice, the report depicts the main education policies regarding teaching and learning of languages in 42 European education systems. It also answers questions about what foreign languages are learnt, how long students spend studying foreign languages, the level of foreign language proficiency students are expected to reach by the end of compulsory education and what kind of language support is provided to newly arrived migrant students. Although the main focus of the report is on foreign languages, some information about the regional/minority and classical languages in the curriculum is provided. The indicators are organised into five different chapters: Context, Organisation, Participation, Teachers and Teaching Processes. A variety of sources were used to build the indicators, and these include the Eurydice Network, Eurostat, and the OECD's PISA and TALIS international surveys. The data cover all countries of the European Union as well as Bosnia and Herzegovina, Switzerland, Iceland, Liechtenstein, Montenegro, the Former Yugoslav Republic of Macedonia, Norway, Serbia and Turkey. http://bit.ly/2qucm7Y

PISA 2015 Results (Volume IV) - Students' Financial Literacy

The OECD Programme for International Student Assessment (PISA) examines not just what students know in science, reading and mathematics, but what they can do with what they know. PISA 2015 Results (Volume IV): Students' Financial Literacy, explores students' experience with and knowledge about money and provides an overall picture of 15-year-olds' ability to apply their accumulated knowledge and skills to real-life situations involving financial issues and decisions. According to the study, around one in four students in the 15 countries and economies that took part in the latest OECD Programme for International Student Assessment (PISA) test of financial literacy are unable to make even simple decisions on everyday spending, while only one in ten can understand complex issues, such as income tax. Beijing-Shanghai-Jiangsu-Guangdong (China) had the highest average score, followed by the Flemish Community 4 Eurodesk Brussels Link Bulletin - June 2017

EuroMed Exchange Programme

Launched by the Anna Lindh Foundation (ALF), the EuroMed Exchange Programme offers young talents and key actors, such as members of civil society organisations, traineeship opportunities across 42 Euro-Mediterranean countries, aiming to support knowledge exchange, strengthen dialogue and intercultural cooperation that are crucial for the stable and sustainable development in the Region. The programme is designed to support synergies, crossdisciplinary activities and new project ideas related to intercultural dialogue (ICD), involving young actors from both shores of the Mediterranean, giving them the spaces to gain new perspectives on how to drive development and make positive changes. Applications are welcome from key actors working on projects related to: Migration and Intercultural Cities, Antiradicalisation and Gender and Translation and Publishing.

The Programme works on two modalities:

- Twinning Exchange: an organisation can send an ICD Actor and host another ICD Actor. The organisations have to be in different countries. The exchanges don't need to take place at the same time.
- Sending Exchange: an organisation can send an ICD Actor to be hosted by another organisation. The organisations have to be in different countries.

Priority will be given to North-South twinning exchanges between members and between members&non-members. However, South-South and West-East (Europe) patterns will also be supported.

Traineeship at CEDEFOP

CEDEFOP, the European Centre for the Development of Vocational Training, is offering one nine-month period of in-service training stage for young university graduates but also to PhD students, without excluding those who, in the framework of lifelong learning, have recently obtained a university diploma and are at the beginning of a new professional career. Trainees are selected only from nationals of the <u>Member States of the</u> <u>European Union and of candidate countries</u>. The training period involves work experience in one of the departments of CEDEFOP and runs from 1st October to end of June each year.

Trainees are awarded a monthly maintenance grant:

- EUR 919.4 per month for trainees from abroad (member states of the EU or candidate countries), as well as trainees residing in Greece who need to move to Thessaloniki for the duration of the traineeship.

- EUR 689.5 per month for trainees residing in Thessaloniki prior to the start of their in-service training.

Travel expenses (within certain limits) are also reimbursed. In order to facilitate equal participation, disabled trainees may receive a supplement of the basic grant.

Highlights

European Solidarity Corps: Commission proposes more than ${\small {\small { € 340 } }}$ million

On 30^{th} May the European Commission proposed a budget for the next three years of the European Solidarity Corps and a dedicated legal base.

The proposed \in 340.5 million budget plans to give 100,000 young people the chance to volunteer, train or work for solidarity projects by 2020.

Four kinds of activities are proposed to be supported by the European Solidarity Corps:

- Solidarity placements supporting young people in carrying out volunteering activities for up to 12 months, traineeship placements for usually 2-6 months, and job placements in compliance with relevant national legislation for 2-12 months. - Volunteering teams allowing groups of 10-40 young volunteers from different countries to make an impact together, for 2 weeks to 2 months.

- Solidarity projects allowing small groups of at least five participants to set up and implement solidarity projects at the local level on their own initiative, for 2 to 12 months.

- Networking activities attracting newcomers to the European Solidarity Corps, allowing the exchange of good practices, providing post-placement support and establishing alumni networks.

All of these actions will give young people across Europe new opportunities to engage in solidarity activities addressing societal challenges and strengthening communities. In parallel, they will help improve the skills and competences young people need for their own personal and professional development at the beginning of their careers. The European Solidarity Corps is an inclusive initiative. Targeted measures, such as additional funding or placements of shorter duration, will promote the participation of disadvantaged young people.

The draft Regulation now needs to be adopted by the European Parliament and the Council of the EU before it can enter into force.

Youth initiative: Commission sets out strategy for high quality, inclusive, future-oriented education

On 30th May the European Commission adopted new initiatives on school and higher education, including a proposal on graduate tracking to help Member States collect information on what graduates do after their studies.

The aim of these initiatives is to help Member States provide high quality and inclusive education for all young people through a series of concrete actions, so they acquire the knowledge and skills needed to participate fully in society, are able to respond to new opportunities and challenges opened up by, for instance, globalisation and technological change, and can tailor their education to the needs of the labour market.

With regard to schools, evidence from Member States show three areas where action is needed and where EU support can help address important challenges:

- Raising the quality and inclusiveness of schools;
- Supporting excellent teachers and school leaders;
- Improving the governance of school education systems.

The Commission is proposing to complement actions taken by Member States in these three areas by supporting mutual learning, strengthening the evidence for what works in education and assisting national reforms for Member States that so wish. Examples of such support include boosting competence development and intercultural learning through school partnerships, mobility and e-Twinning projects under Erasmus+; strengthening peer learning on the careers and professional development of teachers and school leaders; and setting up a new support mechanism to help Member States seeking assistance in designing and implementing education reforms.

The renewed higher education strategy builds on the 2011 Modernisation agenda. In the Communication adopted today, the Commission sets out its plans for four key areas:

- Ensuring graduates leave higher education with the skill sets they and the modern economy need;
- Building inclusive higher education systems;
- Making sure higher education institutions contribute to innovation in the rest of the economy;
- Supporting higher education institutions and governments in making the best use of the human and financial resources available.

Finally, to ensure that higher education can help boost growth and job creation, universities need to tailor curricula to current and anticipated needs of the economy and society, and prospective students need up-to-date, solid information to help them decide what courses to choose. This is why the Commission is in parallel presenting a proposal for a Council Recommendation on graduate tracking, as part of the new Skills Agenda for Europe, which will also cover graduates from vocational education and training programmes in addition to higher state authorities to improve the quality and availability of information on how they progress in their careers or further education after finishing their studies. http://bit.ly/2qBQTHg

Eurostat release: April 2017 Euro area unemployment rate

According to Eurostat, the statistical office of the European Union, in April 2017, 3.746 million young persons (under 25) were unemployed in the EU28, of whom 2.617 million were in the Euro area. Compared with April 2016, youth unemployment

decreased by 600 000 in the EU28 and by 419 000 in the Euro area.

In April 2017, the youth unemployment rate was 16.7% in the EU28 and 18.7% in the Euro area, compared with 19.0% and 21.4% respectively in April 2016. In April 2017, the lowest rate was observed in Germany (6.8%), while the highest were recorded in Greece (47.9% in February 2017), Spain (39.3%) and Italy (34.0%). http://bit.ly/2smwEyy

Education, Youth, Culture & Sport Council Conclusions

On the Education, Youth, Culture and Sport (EYCS) Council, which took place in Brussels, Belgium, on 22nd and 23rd May 2017, Ministers adopted a Resolution on the future development of the (sructured) dialogue with young people in the context of policies for European cooperation in the youth field post-2018. The Resolution outlines the main priorities for the next cycle of the dialogues, which will have as its main theme "Youth in Europe: what's next?. The Resolution calls for a review on how to improve the dialogue and make it more effective in the future. It also calls for particular attention to be given to ways of developing a constructive dialogue and cooperation with young people from diverse backgrounds, youth researchers and policy makers and interested parties from other related sectors. Ministers also adopted Conclusions on the strategic perspectives for European cooperation in the youth field post-2018, which will provide guidance to the Commission as it carries out a midterm evaluation of the key policy instrument in this area, the "EU Youth Strategy". The Conclusions underline the need for the future strategy to be cross-sectoral, flexible, responsive and transparent and take account of the rapidly changing political, social, cultural and economic situation in Europe. Ministers adopted Conclusions on the role of youth work in supporting young

people's development of essential life skills to facilitate their transition to adulthood, active citizenship and working life.

In the field of education, ministers dopted a Recommendation on the European Qualifications Framework for lifelong learning. Its aim is to improve the transparency, comparability and portability of qualifications across Europe by establishing a common reference framework for national qualifications systems. The Recommendation also seeks to help modernise education and training systems and increase the employability, mobility and social integration of workers and learners. The Council took note of progress on Europass, which is intended to help increase mobility in Europe by providing a framework which will improve access to information on skills and qualifications for education and employment purposes.

In the field of Sport, the Council adopted a Resolution on the European Union Work Plan for Sport (2017-2020). The Work Plan has a limited number of policy initiatives tackling key issues such as the fight against doping, combating match-fixing and improving good governance in sports organisations. Emphasis is placed on combating corruption, safeguarding minors, developing

links between sport and the digital single market, including media rights, as well as on education within and through sport, the role of coaches and sport diplomacy. Ministers also adopted Conclusions on sport as a platform for social inclusion and, as a follow-up, they discussed how to develop a media policy that supports social objectives in sport.

In the field of culture, ministers reached a General Approach on the proposal for a revised Directive on audiovisual media services (AVMS). The proposal aims to make this legislation better fit to the digital age, for instance, by extending its scope to video-sharing platforms. The proposal also establishes stricter obligations for the promotion of European works for ondemand services. Ministers also adopted Conclusions on a EU strategy for international cultural relations, in the follow-up to the Commission and the EU High Representative joint Communication on a EU strategy for international cultural relations.

2017 Charlemagne Youth Prize Winners

The Polish project Erasmus Evening, an online radio show for students considering to study for a period abroad as part of the Erasmus programme, has been awarded this year's Charlemagne Youth Prize. The prize is given out by the European Parliament and the International Charlemagne Prize Foundation every year to young people aged between 16 and 30 who have been involved with projects helping to promote understanding between people from different European countries. The ceremony took place on 23rd May 2016, in Aachen, Germany. The other winning projects are "Re-discover Europe", an event that took place in Aalborg (Dk), featuring a parade with EU flags, talks about the future of Europe, a multicultural village about the city's rich diversity and a street party and "Are We Europe", a Dutch online multimedia platform where young people can submit their stories portraying what it is like being European. http://bit.ly/2rTTkWA

Eurobarometer survey: Attitudes of Europeans towards tobacco and electronic cigarettes

According to the European Commission survey on the "Attitudes of Europeans towards tobacco and electronic cigarettes", there is no decrease in the overall smoking rate in the EU (26%) since 2014. Amongst people aged 15 to 24 the rate has increased from 25% in 2014 to 29% in 2017. Significant differences exist between EU countries, with the highest smoking rates in Greece (37%), Bulgaria, France (both 36%) and Croatia (35%). At 7%, Sweden has the lowest smoking rate in the EU. Regular e-cigarette use remains stable at 2%, with 15% having tried such products at some point. With regard to attitudes to tobacco and e-cigarette control measures, the majority of those surveyed (63%) think ecigarette use should be banned in places where there are smoking bans; and 46% are in favour of plain packaging for cigarettes. http://bit.ly/2rAh9Xb European Commission Survey on Education, Training & Employment The survey aims to better understand end users' needs for online tools in the field of skills and qualifications. It will help shaping the future developments of existing European tools and services related to education and employment. The survey is addressed to individuals, organisations and other stakeholders such as job-seekers, pupils/students, workers, employers, education or training providers and guidance and counselling advisors. Lifelong Learning Platform Erasmus+ Survey

Organised by the Lifelong Learning Platform, the survey aims to provide decision-makers with feedback from the programme's direct beneficiaries on what works and what could be improved. The survey contains questions on various aspects related, for instance, to the application procedures, to the relations with the national and European agencies, financial rules and the reporting processes. The survey is available <u>here</u> until **30th June 2017**. It will take not more than 10 minutes to fill it in. Results will be presented at the launch of the LLLWeek2017, in November 2017.

EU-CoE youth partnership Survey on Youth work and young refugees in Europe

Launched by the EU-CoE youth partnership, the survey aims to strengthen the knowledge and awareness on the added value of youth work and serve as an inspiration for policy makers, researchers and practitioners working towards inclusion and integration of young refugees. The survey looks for a wide variety of practices that will allow to map the diversity and richness of the contribution of the youth sector for the inclusion of young refugees and their access to rights, and integration initiatives in the hosting community. The survey is available here until **27thJune 2017**.

Recommendation of the Committee of Ministers to Member States on youth work adopted

On 31st May 2017 the Committee of Ministers of the Council of Europe adopted Recommendation CM/Rec(2017)4 to Member States on youth work. Drawing on the Declaration of the 2nd European Youth Work Convention (2015), the document encourages Member States to develop their youth work policy and practice within their sphere of competence and invites them to adopt a range of measures that will strengthen the necessary support for youth work at local, regional, national and European levels. As participation is one of the key principles of youth work, young people, youth workers, youth and other organisations providing youth work are recognised as active partners in the development, implementation and evaluation of youth work policy and practice. Member States are encouraged to secure the active participation all these stakeholders when taking forward the of recommendations.

Among the recommendations, Member States are invited to promote the role of youth work by informing young people of their rights and of the opportunities and services available to them; strengthening the active citizenship, participation and social inclusion of all young people, especially those who are at risk and marginalised; broadening intercultural competences, European identity and international understanding among young people; encouraging young people to advance the Sustainable Development Goals (SDG) in their living environment; addressing and preventing discrimination, intolerance and social exclusion; enhancing non-formal and informal learning; respecting the freedom and autonomy of youth organisations and other nongovernmental organisations (NGOs) doing youth work; fostering knowledge-based youth work that can respond to the changes and trends in our societies and the emerging challenges faced by young people; encouraging the use of research, evaluation and continuous follow-up in developing knowledge-based, quality youth work ensuring that mechanisms are in place to measure its outcomes and impact.

Council of Europe Action Plan on protecting refugee and migrant children adopted

On 19th May 2017 in Nicosia, Cyprus, during the 127th Session of the Committee of Ministers, 47 European states adopted an Action Plan on protecting refugee and migrant children (2017-2019). Coordinated by the Special Representative of the Secretary General on Migration and Refugees, Ambassador Tomáš Boček, the Council of Europe-wide Action Plan aims at addressing the main concerns identified in the Special Representative's Thematic Report on migrant and refugee children. The Action Plan proposes concrete support to member states at all stages of the migration process, with a special focus on unaccompanied children, and has three main pillars: ensuring access to rights and child-friendly procedures; providing effective protection and enhancing the integration of children who would remain in Europe. The measures to be taken in protecting the refugee and migrant children include: new guidelines regarding age assessment and guardianship, alternatives to detention and a handbook on promoting child-friendly information and training on childfriendly procedures. Different sectors of the Council of Europe will contribute to the implementation of the Action Plan, including those dealing with children's rights, education, sports, youth participation and the media. http://bit.ly/2ryFZCU

Over 1,300 Erasmus Mundus Scholarships Awarded for 2017

1,345 students from around the world have been awarded EU-funded scholarships to begin Erasmus Mundus Joint Master Degrees this autumn. Erasmus Mundus Joint Master Degrees are prestigious, international study programmes, jointly delivered by a consortium of higher education institutions. Scholarships have been awarded to students from all 6 continents with the top 5 sending countries being Brazil (79), India (63), Iran (59), Bangladesh (58), Mexico (49). The scholarships will cover all

the costs of the students' study programmes taking them to two or more higher education institutions in pursuit of a joint or double Master's degree. Most programmes last two years. The 100 Erasmus Mundus Joint Master Degree programmes offering EU scholarships in 2017 cover a wide range of subjects, from astrophysics and nanotechnology to cartography and sports ethics. The selected students will also be able to join and benefit from the Erasmus Mundus Student and Alumni Association, which supports and provides a network for students before, during and after their studies. Each Master's programme also provides EU grants to guest academics to come and contribute to the programme through teaching or research. Some 40 new Master's programmes will be added to the Erasmus Mundus catalogue this summer, making an even wider range of programmes available for scholarship applications for the next selection round. This application period, for students who wish to start their programme in autumn 2018, will be open from October 2017 until January 2018.
