#### The EP and the expectations of European citizens

The European Parliament survey, carried out between 18th and 27th March 2017 through face-to-face meetings with 27 901 EU citizens in the 28 Member States, finds that EU membership is a good thing in the eyes of 57% of Europeans, up by four percentage points compared to the previous survey of September last year and almost at the same level as in 2007 (58%), before the and economic crisis set in. Percentages significantly, however, from country to country. Reacting to the latest geopolitical events, such as the growing instability in the Arab world, the increasing influence of Russia and China, Brexit and the election of Donald Trump, up to 73% of respondents prefer the EU to find a common response over individual national actions. A strong majority also calls for the EU to do more in addressing current challenges, such as the fight against (80%) and unemployment (78%), protecting environment (75%) and tackling tax fraud (74%). An increasing number of Europeans (43%) feels that their voices count at EU level, more than at any other time since 2007 and up by 6 points compared to 2016. By contrast, six Europeans in 10 consider that their voice counts in their country, which is 10 points more than in 2016. Finally, the overwhelming majority of Europeans say that inequalities between social classes are significant and a third of them doubt that the crisis will be over for many years.

# Getting Skills Right - Financial Incentives for Education and Training systems

Published by the Organisation for Economic Cooperation and Development (OECD), the Report examines how governments use financial incentives to promote a better alignment between labour market needs, on the one hand, and the supply of skills, on the other.

In doing so, the report identifies innovative models that countries may be interested in learning from; best practice in the design and use of financial incentives; framework conditions for their effective use and limitations and risks in the use of financial incentives.

### PISA 2015 Results (Volume III) - Students' Well-Being

The OECD Programme for International Student Assessment (PISA) examines not just what students know in science, reading and mathematics, but what they can do with what they know. Results from PISA show educators and policy makers the quality and equity of learning outcomes achieved elsewhere, and allow them to learn from the policies and practices applied in other countries. PISA 2015 Results (Volume III): Students' Well-Being, is one of five volumes that present the results of the PISA 2015 survey, the sixth round of the triennial assessment. It explores a comprehensive set of well-being indicators for adolescents that covers both negative outcomes (e.g. anxiety, low performance) and the positive impulses that promote healthy development (e.g. interest, engagement, motivation to achieve). According to the study, children spend a considerable amount of time in the classroom: following lessons, socialising with classmates, and interacting with teachers and other staff members. What happens in school – as well as at home – is therefore key to understanding whether students enjoy good physical and mental health, how happy and satisfied they are with different aspects of their life, how connected to others they feel, and the aspirations they have for their future.

#### EUROFOUND Report: Social Mobility in the EU

EU citizens are increasingly concerned that today's young people will have fewer opportunities for upward social mobility than their parents' generation. This report maps patterns of intergenerational social mobility in the EU countries. It first looks at absolute social mobility, how societies have changed in terms of structural and occupational change and societal progress. Then it turns to relative social mobility ('social

fluidity'), the opportunities for individuals to move between occupational classes. The story of recent social mobility is explored using data from the European Social Survey (ESS) and findings from Eurofound's Network of European correspondents across the EU Member States. The report also analyses the current policy discourse, examining to what extent social mobility has been visible on the policy agenda in different Member States and how it has been framed and discussed. It goes on to look at barriers to equal opportunities and policies to promote it. Finally, it focuses on developments in the last decade that could foster social mobility in childhood and early education, school and tertiary education, and the labour market. According to the Report, younger Europeans are likely to have fewer opportunities for upward social mobility than preceding generations. Social mobility in Europe seems to have stagnated, at least in some countries, with opportunities for upward social mobility only increasing in a minority of EU countries for all age groups; in some Member States there is even evidence of a decline in social mobility.

#### Special report No 5/2017: Youth unemployment - have EU policies made a difference?

Published by the European Court of Auditors (ECA), the report examines the progress made by the EU Youth Guarantee in ensuring that under 25s receive an offer of employment, education, apprenticeship or training within four months of leaving school or becoming unemployed. It also evaluates the Youth Employment Initiative, which increased financial support for struggling the most. The report finds limited progress and results which fall short of expectations with regard to providing a good quality offer to all NEETs (those not in employment, education or training). In order to to improve the current and future initiatives in the area of employment, the report recommends to the European Commission and to the Member States to manage expectations by setting realistic and achievable objectives and targets; perform gap assessments and market analyses prior to setting up schemes and improve their monitoring and reporting systems. The report also invites Member States to establish a complete overview of the cost of the Youth Guarantee and tailor schemes to available financing, ensure that offers employment, education or training match participants' profiles and labour market demand, and therefore lead to sustainable employment. Finally, it invites the European Commission to ensure that Member States justify how their EUfunded youth employment measures will adequately address their needs.

#### A Sea of Words - International Short Stories Contest

The Anna Lindh Foundation and the European Institute of the Mediterranean are inviting young people, from 18 to 30 years old, from the 43 countries of the Euro-Mediterranean area, to join the contest. On its 10th Anniversary, under the motto "Youths, Stereotypes and Radicalisation", the contest gives Euro-Mediterranean youths the opportunity to explain their experiences related to how they see themselves and how society imposes a series of stereotypes on them. The short stories must be original and unpublished works, of maximum 2,500 words, and can be written in any of the official languages of the participant countries. The authors of the 15 best short stories will be invited to a writing workshop (18th October 2017), to a guided tour of Spain (19th October 2017) and to the awards' presentation ceremony in Barcelona, Spain, on 17th October 2017. Coinciding with the 10th year of the contest, three winners from past years who have achieved success in the literary world will be invited to participate in these activities.

The stories selected will be published in a book in digital format with the texts in the original language and their corresponding English translation (December 2017).

#### The Intercultural Innovation Award

The Award is a partnership between the United Nations Alliance of Civilisations (UNAOC) and the BMW Group, aiming to support most innovative grassroots projects that encourage intercultural dialogue and cooperation around the world. The Award is addressed to Not-for-profit organisations managing projects focused on promoting intercultural dialogue and understanding, and who are willing to expand their range of action. They can be non-governmental organisations, charitable organisations, research and educational institutions, labor indigenous groups, faith-based organisations, professional associations, foundations and local or municipal branches of government. Applying organisations must have been operational for a minimum of 2 years before April 2017; with funding base and project implementation (i.e. the organisation must show registration in their country of operation by April 2015 or earlier). Applying organisations must be managing a focused on promoting intercultural dialogue and understanding. Examples include projects in the fields of xenophobia, education for global citizenship, interfaith dialogue, migration and integration, prevention of violent extremism, as well as initiatives addressing the needs of specific groups in promoting intercultural understanding (e.g. faith-based, youth, women, media, etc.)

Ten organisations with potential for expansion and replication will be awarded funding and strategic support. The awardees will be announced at the Intercultural Innovation Awards Ceremony.

#### Traineeship at the European Medicines Agency

#### Reaching more young people

As part of a joint project "Reach More Young People: Promotion of Youth Work and Youth Information Services", Eurodesk, Eyca and Eryica ran an online survey from 1<sup>st</sup> February to 15<sup>th</sup> March. Based on the outcomes, a training seminar took place from 5<sup>th</sup> to 7<sup>th</sup> April in Brussels. It sought to provide youth information workers with the tools and skills needed to succeed in reaching as many young people as possible, and especially those that need it the most. An ePublication will be released soon to showcase best practices in the field. This event took place in the framework of the Memorandum of Understanding between the three networks and follows the adoption of a joint position paper on the EU Youth Strategy "Engage. Inform. #### Legal proposal to consolidate and further shape the European Solidarity Corps

On 24th May 2017, the European Commission is expected to adopt a legislative proposal on the European Solidarity Corps, as announced at its launch in December 2016. The new dedicated legal base will consolidate the current first phase of this  $\bar{\text{new}}$  initiative that builds on existing financing programmes, and further shape the European Solidarity Corps. It will include a dedicated budget and lav the basis for a robust roll-out in order to allow 100,000 young people to take part by the end of 2020. To prepare this proposal, the Commission launched both an open online survey and targeted consultations with stakeholders, culminating in a Stakeholder Forum on 12<sup>th</sup> April. Altogether 660 individuals and organisations responded to the consultation and around 700 people attended the Stakeholder Forum.

The feedback received from young people, organisations, civil society and national authorities was largely positive, welcoming the visibility and political recognition given to young people's engagement in solidarity, and the increased opportunities for young people to contribute through the European Solidarity Corps.

#### Five cities shortlisted for European Youth Capital 2020

Five cities have been shortlisted by an independent jury for the final stages the European Youth Capital (EYC) 2020 competition. (Moldova), are Amiens (France), Chisinău (Lithuania), Timisoara (Romania) and Villach (Austria). The five shortlisted cities were selected from a pool of applicants from right across Europe and will now progress to the second round of the competition. The cities will have two months to submit an extensive programme of youth-related cultural, social and political events and activities, and outline a partnership between the municipality and the city's young people to create, plan, and run the EYC year.

#### Eurostat release: Temporary employment in the EU

According to Eurostat, the statistical office of the European Union, 6.4 million employees aged 15 to 64 in the European Union had a temporary contract in 2016. In the EU in 2016, 43.8% of employees aged 15 to 24 were employed under a temporary contract. More than 7 in 10 young employees had a temporary contract in Slovenia (74.0%), Spain (72.9%) and Poland (70.7%). Around twothirds of them had such contracts in Portugal (66.3%) and Croatia (64.6%), while more than half of young employees in France (58.6%), the Netherlands (55.6%), Italy (54.7%), Sweden (54.2%) and Germany (53.2%) were affected. In contrast, this share was less than 10% in Romania (5.3%), Lithuania (7.8%) and Latvia (8.3%).

#### Eurostat release: March 2017 Euro area unemployment rate

According to Eurostat, the statistical office of the European Union, in March 2017, 3.883 million young persons (under 25) were unemployed in the EU28, of whom 2.727 million were in the area. Compared with March 2016, youth unemployment decreased by 439 000 in the EU28 and by 268 000 in the Euro area. In March 2017, the youth unemployment rate was 17.2% in the EU28 and 19.4% in the Euro area, compared with 19.1% and 21.3% respectively in March 2016. In March 2017, the lowest rate was observed in Germany (6.7%), while the highest were recorded in Greece (48.0% in January 2017), Spain (40.5%) and Italy (34.1%).

#### European Parliament Decision on 2018 as European Year of Cultural **Heritage**

On 27th April the European Parliament adopted the Decision establishing 2018 as the European Year of Cultural Heritage by a large majority. MEPs secured € 8 million for cultural projects aiming to protect and promote Europe's shared cultural heritage, as part of the 2018 European Year of Cultural Heritage. The vote followed a political agreement by the European Parliament and the Council in February this year. The Council is expected to formally adopt the Decision in May. The European

Year of Cultural Heritage will be a European initiative with a series of events taking place at all levels: European, national,

regional and local. It will be an opportunity to involve citizens from all backgrounds, in particular children and young people, in events and projects emphasising Europe's heritage and values, helping to strengthen a sense of belonging to a European family. The objective is to allow increased access to heritage for all and encourage people to get involved in managing and caring for

The Year will provide the opportunity to debate, reflect on and make a 'quality leap' in preserving and restoring heritage. The Year is also expected to raise awareness of the wide array of EU funding opportunities cultural heritage can benefit from, such as programmes for the environment, through the Natura 2000 sites, other programmes on cultural tourism, citizenship, and external relations or Erasmus+, the EU programme for education, training, youth and sport.

#### European Pillar of Social Rights

On 26th April the European Commission presented the European Pillar of Social Rights. The Pillar sets out 20 key principles and rights to support fair and well-functioning labour markets and welfare systems, which are structured around categories: equal opportunities and access to the labour market fair, working conditions, social protection and inclusion. A number of principles and rights included in the Pillar will require further legislative initiatives to become effective. Where needed, existing EU law will be updated, complemented and better enforced.

A social scoreboard has also been established to track trends and performances across EU countries in 12 areas and to assess progress towards a social "triple A" for the EU as a whole. This analysis will feed into the European Semester of economic policy coordination. The Pillar is presented both as a Commission Recommendation, and as a proposal for a joint proclamation by the Parliament, the Council and the Commission. The Commission will now enter into discussions with the European Parliament and all the Member States in the Council to work towards broad political support and high-level endorsement of the Pillar. http://bit.ly/2oLdxwE

Eurostat release - Europe 2020 education indicators in 2016

According to Eurostat, the statistical office of the European Union, the share of persons aged 30 to 34 in the European Union (EU) who have completed tertiary education continued to steadily increase, from 23.6% in 2002 when the series started to 39.1% in 2016. This pattern was even more significant for women (from 24.5% in 2002 to 43.9% in 2016, meaning above the overall Europe 2020 target) than for men (from 22.6% to 34.4%, meaning still below the overall Europe 2020 target). The Europe 2020 strategy's target is that at least 40% of 30-34-year-olds in the EU should have completed tertiary education by 2020. Meanwhile, the share of early leavers from education and training (aged 18-24) has steadily decreased in the EU, from 17.0% in 2002 to 10.7% in

2016. Young women (9.2% in 2016) are less affected than young men (12.2%).

The Europe 2020 target is to reduce the rates of early school leaving in the EU to below 10% by 2020. http://bit.ly/2pkKoeR
