# **Documentation**

#### The European Higher Education Area in 2018: Bologna Process Implementation Report

The Report presents a picture of how the European Higher Education Area (EHEA) has been moving forward since the Yerevan Conference in 2015. By using qualitative information and statistical data, the report outlines the current state of play of the Bologna Process from various stakeholders' perspectives, through its seven chapters: the European Higher Education Area Landscape; Learning and Teaching; Degrees and Qualifications; Quality Assurance and Recognition; Opening Higher Education to a Diverse Student Population; Relevance of the Outcomes and Employability; Internationalisation and Mobility. It shows that most countries have been focused on consolidating the implementation of reforms in recent years. Although some countries require further support to ensure that these reforms are fully implemented, the report shows that real progress has been achieved in creating an open and inclusive higher education area thanks to the fundamental commitments that underpin the EHEA. The report also fully addresses the Bologna Process's other priorities outlined in the Yerevan Communiqué: learning and teaching, social inclusion and employability. https://bit.ly/2Lsah4T

# **Eurobarometer 2018: Democracy on the Move**

The latest European Parliament Eurobarometer survey, published one year ahead of the European elections in May 2019, shows a continuous increase in citizens' support for the European Union. Over two-thirds of respondents (67%) are convinced that their country benefits from being a member of the EU. This is the highest score ever measured since 1983. Also, for the first time, a majority of respondents (48%) believes their voice counts in the EU. The survey also takes a look at citizens' perceptions of voting. Civic reasons - such as 'it is their duty as citizens' - come first when Europeans are asked why they think people would vote in the European elections. A great majority think that people would abstain because 'they believe that their vote will not change anything', 'they distrust the political system' or 'are not interested in politics or in elections in general'. The lack of information is also a relevant element to be considered. Technical reasons also play a considerable role as 15% of respondents believe that people would not vote as they might have 'no time or something more important to do', while 12% 'do not know where or how to vote'.

# **Youth Progress Index**

Published by the European Youth Forum, the Index is one of the first instruments developed to give the full story of what life is like for a young person today, independent of economic indicators. It collects reliable, relevant data to give each country a score on how well different countries meet Basic Human Needs, Foundations of Wellbeing, and Opportunity. By measuring factors that matter to and can impact the daily lives of young people, the Youth Progress Index allows to get a much clearer picture of young people's wellbeing and countries' performance in areas such as education, healthcare, housing and environmental sustainability.

# Youth Work Against Violent Radicalisation - Theory, Concepts And Primary Prevention In **Practice**

Published by the EU-CoE youth partnership, the study presents ways in which youth work prevents radicalisation leading to violence. It also identifies inspiring youth work practices, as well as the needs and challenges youth work faces. The research identifies individual, relational, community and macro-systemic factors, as well as opportunities and trajectories, which may turn young people towards radicalisation and the use of violence, but it also notes that each process of radicalisation leading to violence is unique and different, and it is not possible to create "checklists" for identifying youth prone to violent radicalisation. The 20 practices included in this research offer different perspectives on how diverse youth work approaches and methods can shape young people's attitudes, perceptions and behaviours. These practices are grouped in five categories: peer education; online campaigns and digital media; co-operation with other stakeholders; providing opportunities; and education and training.

# **OECD Youth Stocktaking Report**

The Report takes stock of existing public governance arrangements for effective and inclusive youth engagement and empowerment. It draws on OECD evidence on open government, gender equality, public sector innovation, public budgeting, regulatory policy, and other areas. In the field of youth policy, the report finds that less than half of all OECD countries have an operational national youth strategy in place. Some do not seem to deliver on international standards. A variety of practices exists to steer and co-ordinate youth affairs across ministries and levels of government. However, there are gaps in the available evidence on the workforce and budgets allocated for delivering youth policy and services. Only a small number of countries apply tools to mainstream youth concerns in policy making and service delivery, and sound evidence on their impact is missing.

According to the report, young people are underrepresented in state institutions and participation in public and political life through formal channels appears to be on the decline. Governments and youth have yet to fully harness the potential of alternative avenues for youth to shape policy outcomes. Concerning legal frameworks and minimum ages, while a legally binding international framework focused on "youth" does not exist, youth laws/acts have emerged in some countries. However, in some cases, contested minimum ages continue to undermine young persons' access to public services and autonomy.

# **Opportunities**

#### **DiscoverEU**

New EU initiative offering 18 year old EU citizens the opportunity to discover their continent. With a budget of EUR 12 million in 2018, this action, based on a proposal from the European Parliament, is expected to give 15,000 young people the opportunity to travel around Europe to discover the continent's rich cultural heritage, get in touch with other people, learn from other cultures and as such discover what unites Europe. Participants will be able to travel up to 30 days and visit between 1 and 4 foreign destinations. As 2018 is the European Year of Cultural Heritage, travellers will also have the chance to participate in the many events that are taking place all over Europe.

In an application round to select the first 15,000 travellers, those interested will have to apply over a two-week period in the month of June 2018 via the European Youth Portal. Applicants must be 18 years old on 1st July 2018 (born between 2nd July 1999 and 1st July 2000 included), EU citizens, and prepared to travel this summer between 9th July and 30th September 2018. Once selected, they will be free to travel from 1 day and up to 30 days inclusive and visit from 1 up to 4 foreign country destinations within the EU. Entrants can apply as individuals or as a group of maximum 5 people.

Applications must be submitted through the European Youth Portal from 12th June to 26th June 2018, 12:00 CET.

Applicants will have to answer six quiz questions linked to the 2018 European Year of Cultural Heritage, European Union initiatives targeting young people and the European Parliament elections, plus a tie-breaker question.

A jury will make the final selection of the first 15,000 recipients.

A second round of applications in the second half of 2018 may be organised based on the remaining budget and feedback from participants travelling this summer.

# Traineeships at the European Food Safety Authority (EFSA)

The European Food Safety Authority (EFSA) is offering traineeship programmes enabling trainees to put into practice the knowledge they have acquired during their academic studies or professional careers in the areas of science, communication or administration.

# **Exchanges and mobility in sport**

Launched by the European Commission, this call for proposals EAC/S14/2018, serves to implement the Preparatory action "Promotion of European values through sport initiatives at the municipal level" which aims to contribute to the efforts of sport organisations by supporting the learning mobility of their staff. Exchanges of people, ideas and good practices can be beneficial for the individuals, for their organisations and for sport as a whole. In this context, the action aims to support learning mobility and exchanges while promoting the international dimension of sport by giving the opportunity to staff of sport organisations (athletes entourage) to improve their competences as well as qualifications and acquire new skills through learning mobility by spending a period of time in a foreign country (in and outside of the EU).

The action is targeting coaches and other 'staff' of sport organisations (including volunteers) linked to professional and grassroots sport.

It aims at improving the knowledge and know-how of sport staff and developing international cooperation in the field of learning mobility in sport.

In order to promote the international dimension of sport, cooperation should be between at least 3 organisations established in 3 different EU Member States (the applicant organisation and 2 other organisations established in different EU Member States) and at least one organisation established in a non-EU country in one of the following regions: the Western Balkans, Eastern Partnership, Latin America and Asia.

Projects must be presented by public or private organisations active in the sport and physical activity field and organising sport and physical activities, that are legally registered in one of the 28 EU Member States.

Activities should start before 1st January 2019 and 31st March 2019 and should be completed by 31<sup>st</sup> December 2020.

The minimum duration of projects is 6 months.

The EU grant is limited to a maximum co-financing rate of 80% of eligible costs.

The EU envisages that approximately 5 projects will be financed.

The maximum amount per individual grant will be 240,000 EUR.

# Promotion of European values through sport initiatives at the municipal level

Launched by the European Commission, this call for proposals EAC/S14/2018, serves to implement the Preparatory action "Promotion of European values through sport initiatives at the municipal level" which aims to support organisations that promote sport initiatives at local level with the goal of disseminating the positive values of sport. This action is implemented into two lots.

Lot 1 aims to encourage capacity-building in order to support organisations that promote common values through the development of sport at municipal level throughout the EU. Lot 2 aims to support the establishment of networking links and mutual information sharing activities between municipalities in areas related to sport.

The call is open to legal entities established in EU Member States:

- -For Lot 1, public or private organisation with legal personality, active in the sport and physical activity field and organising sport and physical activities; non-profit organisation (private or public); public authorities (national, regional, local); international organisations; sport clubs; universities; educational institutions; companies;
- -For Lot 2, public body active at local or municipal level in one of the 28 EU Member States; towns/municipalities, other levels of local/regional authorities; federations/associations of local authorities; non-profit organisations representing local authorities.

#### Activities:

- -For Lot 1, organisations need to pursue activities in at least 10 municipalities, all located in different EU Member States.
- -For Lot 2, the applicant public bodies need to establish links with at least 9 public entities (i.e. towns/municipalities, local/regional public authorities, federations/associations of local authorities, or non-profit organisations representing local authorities). The applicant public body and the partner public entities need to be established in at least 3 different EU Member States.

All activities must take place in the EU Member States between 1st January 2019 and 31st March 2019. They will have to be completed by 31st December 2020.

The minimum duration of projects is 6 months.

# Highlights

# **European Commission proposal for Erasmus programme**

On 30<sup>th</sup> May the European Commission proposed the next Erasmus programme, which has the ambition to follow the Commission's vision to work towards a European Education Area by 2025 as set out in its Communication on 'Strengthening European Identity through Education and Culture' of 14th November 2017. For the new Erasmus programme the Commission is proposing to increase its budget to €30 billion from 2021-2027 with €25.9 billion for education and training, €3.1 billion for youth and €550 million for sport.

#### The aim is to:

- Increase the number of beneficiaries: doubling the programme's budget will make it possible to support up to 12 million people between 2021-2027, three times as many as in the current financing period. Beneficiaries include school pupils, higher education students, trainees, teachers, trainers, youth workers, sports coaches, and also learners in vocational education and training and adult learning staff, including those participating in ErasmusPro.
- Reach out to people from all social backgrounds: through new formats and easier access for smaller and grassroots organisations, the new programme will make it easier for people from disadvantaged backgrounds to participate.
- Build stronger relations with the rest of the world: mobility and cooperation with third countries will also be boosted, through a combination of physical and virtual mobility.
- Focus on promoting forward-looking study fields: the strengthened programme will give more attention to study fields such as renewable energy, climate change, environmental engineering, artificial intelligence or design.
- Promote a European identity with a travel experience: the new DiscoverEU initiative will give young people opportunities to discover Europe's cultural heritage and diversity.

# **European Commission proposal for European cultural and creative sectors**

On 30<sup>th</sup> May the European Commission proposed to increase the budget for the programme supporting European cultural and creative sectors (including the audiovisual industry) -Creative Europe, to €1.85 billion for the 2021-2027 period, as part of its proposal for a modern EU budget. The proposal for a new Creative Europe programme is part of the "Investing in people" chapter of the EU's long-term budget proposal. Its main objectives are to promote,

strengthen and protect European cultural and linguistic diversity, cultural heritage and creativity, as well as to reinforce the competitiveness of the European cultural and creative sectors. The increased budget (by €390 million) will also help to support the EU's media freedom and pluralism. The new Creative Europe programme will build on the achievements of the existing actions, aiming to exchange, co-create, co-produce and distribute European works and make them accessible to a wide and diverse audience. The proposed programme will support cross-border partnerships and networks as well as new collaboration models, to encourage the scaling up of Europe's cultural and creative sectors. It will include three strands:

- MEDIA supporting the audiovisual sector;
- CULTURE supporting other cultural and creative sectors;
- CROSS-SECTORAL supporting actions spanning across audiovisual and other cultural

The proposal of the Commission has now to be adopted by the European Parliament and the Council.

# New initiatives to further boost role of youth, education and culture policies

On 22<sup>nd</sup> May 2018 the European Commission presented new initiatives aim to enhance learning mobility and educational opportunities in the EU, empower young people, in particular by encouraging them to participate in civic and democratic life, and harness the potential of culture for social progress and economic growth in Europe. The Commission presented a package including:

- an overarching Communication on 'Building a Stronger Europe: the role of youth, education and culture policies' which outlines how the Commission is taking forward the Gothenburg agenda and the European Council's mandate;
- a Youth Strategy for the period 2019–2027 to empower Europe's youth and give them a stronger voice in EU policymaking;
- proposals for Council Recommendations on High Quality Early Childhood Education and Care Systems to lay the foundations for later success in life; on the Automatic Mutual Recognition of Diplomas and Learning Periods Abroad to facilitate learning mobility in Europe; and on improving the Teaching and Learning of Languages to ensure that more young people become proficient in foreign languages;
- a New Agenda for Culture to raise awareness of Europe's shared, diverse heritage. It aims to use the full potential of culture in building a more inclusive and fairer Union, supporting innovation, creativity, sustainable jobs and growth and in reinforcing the external relations of the EU.

# EU Youth Strategy 2019-2027

On 22<sup>nd</sup> May the European Commission proposed a renewed EU Youth Strategy for 2019-2027. With its Communication "Engaging, Connecting and Empowering young people: a new EU Youth Strategy" the EC plans to focus the new strategy on the following areas of action:

- ENGAGE: Fostering young people's participation in civic and democratic life;
- CONNECT: Connecting young people across the European Union and beyond to foster voluntary engagement, learning mobility, solidarity and intercultural understanding;
- EMPOWER: Supporting youth empowerment through quality, innovation and recognition of youth work.

The new EU Youth Strategy will also develop its cross-sectoral approach by addressing the needs of young people in other EU policy areas.

The Commission proposes some important novelties compared to the current policy framework:

- -A new EU Youth coordinator will channel voices of young people in the Commission, thus allowing young people to contribute to shaping EU policies across areas; the coordinator will strengthen the dialogue with young people, notably via the European Youth Portal and the EU Youth Strategy Platform,
- -A renewed EU Youth Dialogue to take youth concerns better into account and ensure wider outreach, including through innovative formats:
- -Tracking of EU spending for youth in main funding programmes;
- -An agenda for youth work to further improve its quality, innovation and recognition and to allow other sectors to capitalise on the potential of non-formal learning;
- -A clearer link between EU youth policy implementation and related programme activities in Erasmus+ and the European Solidarity Corps.

# **Education, Youth, Culture and Sports Council main results**

The Education, Youth, Culture and Sport (EYCS) Council, bringing together the education, youth, culture and sport Ministers of the EU Member States met on 22<sup>nd</sup> and 23<sup>rd</sup> May 2018. The Council adopted a revised recommendation on key competences for lifelong learning, the aim of which is to update the current recommendation from 2006 and take account of changes such as digitisation and constantly evolving labour markets. The Council also adopted a recommendation on promoting common values, inclusive education, and the European dimension of teaching, as well as conclusions on moving towards a vision of a European Education Area. Ministers had also the opportunity to discuss the potential of universities in promoting regional growth and entrepreneurial and innovative skills, focusing in particular on what measures and incentives politicians can introduce to develop the potential of higher education institutions, and on the role of smart specialisation strategies and synergies. The Council was also informed about a series of important issues, such as the role of education in addressing anti-Semitism, the European schools sport day to take place on 29th September 2018 during the European Week of Sport, and the work programme of the incoming Austrian presidency. Among other things, the presidency will focus on the regulation on Erasmus +, a recommendation on mutual recognition of higher education and school-leaving diplomas, and a recommendation on enhancing the learning of languages.

After an informal lunch on how to reform the existing mechanisms for consulting young people, the so-called structured dialogue on youth, the Council adopted conclusions on the role of youth in building a secure, cohesive and harmonious society, as well as conclusions on the role of youth in addressing the demographic challenges. The Council also discussed the future priorities of the EU youth policy in the presence of Mr. Hassan Al Hilou, Community Leader of the YouthTalks Foundation. The debate was intended to feed the debate on the revised European Youth Strategy. The new strategy sets out proposals to define a European cooperation framework for youth for the period 2019-2024 and focuses, among other things, on the active participation of young people in democratic life in Europe. Finally, ministers were informed about a declaration on the prevention of violent radicalisation, the European Youth Together initiative. In the field of culture, the Council had a policy debate on a long-term vision for the contribution of culture to the EU after 2020. Ministers adopted conclusions on the need of bringing cultural heritage to the fore across policies in the EU. In the field of sport, ministers debated "The future of club and national team competition" in the presence of EUFA president Mr Čeferin. They also adopted conclusions on promoting the common values of the EU through sport, and held a policy debate on the commercialisation of elite sports and the sustainability of the European model of sport. The Council was also informed about the latest meetings of the World Anti-Doping Agency, the declaration "For a Europe of sport".

# Kosovo joins Erasmus+ and Creative Europe programme

On 5<sup>th</sup> June Commissioner Tibor Navracsics, European Commissioner for Education, Culture, Youth and Sport and Mr Kujtim Gashi, Minister of Culture, Youth and Sports of Kosovo, signed an Agreement for the participation of Kosovo in Erasmus+ and Creative Europe. However, before applicants from Kosovo are eligible to participate in the 2018 Creative Europe calls for proposals, the Agreement will have to be ratified by the Kosovar Assembly.

With Kosovo joining Creative Europe all the six Western Balkan countries are now participating in the programme.

#### Consultation on the Future of Europe

On Europe Day, 9th May, the European Commission has launched an online public consultation addressed to all Europeans, asking them what direction they want the European Union to take in the future. The consultation was prepared on 5<sup>th</sup>-6<sup>th</sup> May by a Citizens' panel of 96 citizens from 27 Member States, who came together to draft a 12-question online survey to put to their fellow Europeans. The two-day meeting was hosted by the European Economic and Social Committee. The consultation is part of the ongoing debate on the future of the EU at 27, launched with the Commission's White Paper of 1st March 2017.

The consultation will run in parallel to the ongoing Citizens' Dialogues being organised by the European Commission and by Member States. Almost 700 of these interactive public debates have been held in 160 cities since 2012, and the Commission will increase their frequency between now and the European elections in May 2019, with a target of organising 500 more events. In addition to the Commission's work, Citizens' Dialogues are now being organised by national governments in all Member States, following an initiative from France which received the support of the Heads of State or Government of the future EU27.

The Commission will present an interim report to Member States on the White Paper process at the December 2018 European Council.

A final report will then be presented at the first EU27 Summit in Sibiu, Romania, on 9th May 2019, just a few weeks ahead of the European elections.

How does a "youth-friendly" government and public administration operate? This OECD public consultation process provides a space for young people and youth policy practitioners to answer this question and enrich the Youth Stocktaking report with practical examples. The consultation is open to everyone, from interested citizens to youth workers and activists, governments, representatives of international organisations, NGOs and academics. Based on the feedback received, the OECD Secretariat will prepare a revised version of the report which will be presented at the next meeting of the OECD Public Governance Committee, held on 12<sup>th</sup>-14<sup>th</sup> November 2018 in Paris.

The consultation is available here until 18th July 2018.

#### Eurostat release: April 2018 Euro area unemployment rate

According to Eurostat, the statistical office of the European Union, in April 2018, 3.426 million young persons (under 25) were unemployed in the EU28, of whom 2.433 million were in the Euro area. Compared with April 2017, youth unemployment decreased by 464 000 in the EU28 and by 306 000 in the Euro area. In April 2018, the youth unemployment rate was 15.3% in

the EU28 and 17.2% in the Euro area, compared with 17.2% and 19.3% respectively in April 2017. In April 2018, the lowest rates were observed in Germany (6.0%), Malta (6.8%) and the Netherlands (6.9%), while the highest were recorded in Greece (45.4% in February 2018), Spain (34.4%) and Italy (33.1%).

# **No Hate Speech Movement Campaign Closing Conference**

More than 150 people representing the various stakeholders of the No Hate Speech Movement campaign took part in the Evaluation conference – Is This It? - held at the European Youth Centre, on 10th-12th April. In his speech to the conference, Thorbjørn Jagland, Secretary General of the Council of Europe, stressed that this youth campaign was "the first broad international initiative to tackle hate speech and to address it as a major human rights issue" and it especially succeeded in raising awareness of the extent and risk of hate speech to young people and to all of society. The conference conclusions stress the need to continue work for strengthening Human Rights by using both online and offline platforms, through education, awareness raising and adequate legislative measures.
